


Acquisition of photovoltaic solar panel manufacturers

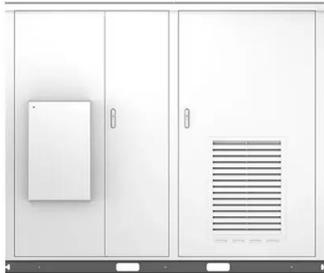

Overview

Swiss electrification specialist ABB has acquired solar PV inverter and power conversion system (PCS) producer Gamesa Electric for an undisclosed sum. Chinese PV provider Skycorp Solar Group has announced a solar plant acquisition and development strategy following. Acquisition supports industry transition to steel solar panel frames to accelerate installation, enhance durability, reduce carbon footprint, and enable local supply chains FREMONT, Calif. -- (BUSINESS WIRE)-- Nextracker (Nasdaq: NXT), a leading solar technology platform provider, today announced. A federal judge approved the asset sale this week following a bankruptcy auction for the Oregon solar and storage site. Otovo, a European solar operations and maintenance service firm headed by former Sunnova CEO, enters California residential market with acquisition of Solar Service Professionals. Materials science giant Corning is betting on US solar, buying Chinese-owned JA Solar's 2 GW factory in Arizona as clean energy tax credit rules tighten. JA Solar's Phoenix-based solar panel factory will now operate under American Panel Solutions, a new subsidiary that Corning owns. "Solar panel frame technology has been relatively unchanged for over 45 years," said Dan Shugar, founder. The solar energy sector has experienced a dynamic landscape of mergers and acquisitions (M&A) over the past decade, reflecting the industry's rapid growth and evolution.




