On , Lithuania officially implemented the amendment to the Electricity Law, requiring that new photovoltaic projects above 100kW must use inverters that meet national safety standards, and existing projects must be transformed before May 2026. Lithuanian lawmakers have adopted legislation designed to limit the ability of Chinese inverter manufacturers to remotely access the country's solar and wind power plants.
